## Broad Spectrum Control of Slugs and Snails

**Active Ingredient:**  
2% Ferric Sodium EDTA

*Slugs & snails are highly sensitive to iron toxicity and are readily attracted to the carriers in IronFist™. Sodium Ferric EDTA is a stomach poison. Once ingested by the slug/snail, IronFist immediately inhibits further feeding and kills them in 1-3 days.*

- IronFist's mode of action is different than metaldehyde based baits, which cause dehydration by destroying the slug's mucus producing cells (typically resulting in a "slime trail").
- Dead slugs and snails may not be visible in areas treated with IronFist, as they often crawl away to secluded places to die.
- Sodium Ferric EDTA has extremely low non-target toxicity; virtually harmless to higher animals including mammals, birds, and fish.
- Earthworms and other ground dwelling beneficials are not affected.
- Can be used around pets and wildlife, with no re-entry restrictions.
- The bait pellets are biodegradable, releasing iron into the soil for plant uptake.
- No aquatic toxicity or ground water contamination issues.

### Application Instructions:

May be applied at a rate of 1/4 to 1 pounds per 1000 ft<sup>2</sup> (1 teaspoon/yd<sup>2</sup>, 10 - 40 pounds/acre). Under normal pest pressure use at the low end of the rate range. Apply at the high end of the rate range if the infestation is severe or after long periods of heavy rain. Scatter the bait on the soil around or near plants to be protected. Re-apply as the bait is consumed. Do not place in piles. Read the entire label prior to use.

Very low toxicity (Oral LD50 = >5000 mg/kg)
Slugs and snails disappear and die, no cleanup
No ground- or surface water contamination
Will not contaminate water when used according to the label directions
Rain Fast, Immediate Irrigation allowed
MRL-exemption allows use on most food crops
Broadcast applications not restricted
No restrictions on contact with plants or edible parts of crops
Can be used around animals (pets) and wildlife. May be used in areas where there are dogs, cats, & birds. Won't harm earthworms. Can be used around grazing animals.
Can be applied to dry and wet soil
First aid language about possible eye irritant
May be re-applied as soon as bait is consumed, no annual maximum

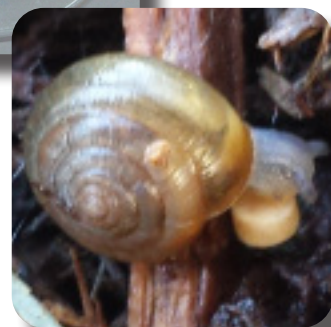
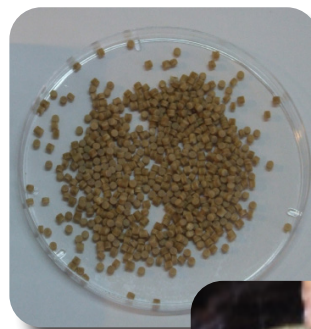
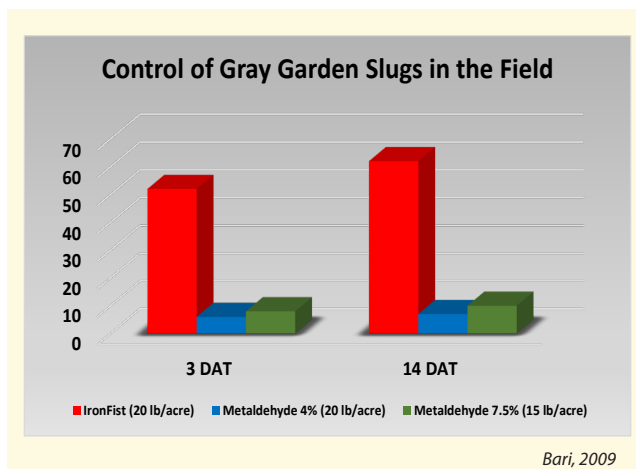
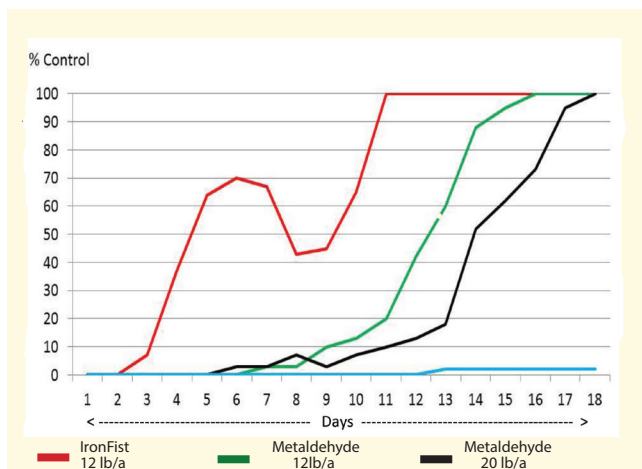


Photo shows snail eating a piece of IronFist.
